Posting of Late-Filed Form Letter Comments

Between approximately November 22, 2023 and June 10, 2024, DOE's Office of Fossil Energy and Carbon Management has received 6,613 similarly worded emails from individuals expressing their opposition to the pending application to export liquefied natural gas (LNG) filed by Venture Global CP2 LNG, LLC (CP2 LNG) on December 2, 2021, and subsequently supplemented (Docket No. 21-131-LNG). The public comment period for the application closed prior to the submission of these comments, on March 11, 2022.
