Subcommittee Scope of Work

Subcommittee Meeting Process

- Subcommittee meets every 2 weeks and tackles 1 topic per meeting
- Topic is discussed in 'round table' fashion (on zoom) and everyone gets an opportunity (~2 min) to provide insight and share knowledge on the topic.
 - Followed by general discussion if time permits
- An action item is assigned to a volunteer to sift & sort meeting insights and craft them into useful products (tables, lists, inventories etc)
- At a subsequent meeting a few weeks later, topic is revisited and materials developed by volunteer are reviewed
- Small group is formed to continue to work the topic and merge it into a chapter section
- To date, 3 out of 6 topics have been addressed in this manner
