Proposed Action Title: Install Cone V-003 Actuator at 681-3G/Removal of Load Shedding Panels in 681-3G

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

The river water cone valves are currently operated via hydraulic oil pressure. Pressurized oil is fed from the oil accumulators to operate a piston within the S. Morgan Smith cone valves. As a risk reduction strategy, the hydraulically actuated valves are scheduled to be retrofitted to provide motor-operated actuation in lieu of hydraulic oil operation. This field change request will remove the existing hydraulic oil lines from FV-003 to allow for the removal of the existing piston and then eventual installation of the new electric actuator. Removal of Load Shedding Panels in 681-3G. Load shedding panels are no longer in operational use.
