

Proposed Action Title: Pyrophoricity testing on hydrogen cycled LaNi4.25Al0.75 (LANA.75) samples

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Pyrophoricity testing on hydrogen cycled LaNi4.25Al0.75 (LANA.75) samples will be performed. This task will determine whether as received or cycled LANA.75 will meet the definition of pyrophoric as defined by the United Nations (7th Edition, 2019) - Section 33.4 (Test N.2 for Pyrophoric Solids).

Pyrophoricity testing will be performed on unloaded samples as well as partially and fully loaded samples. In addition, samples will be characterized to include XRD for crystallinity, ICP for elemental composition, and particle size distribution.
