

Proposed Action Title: Evaluation of Chemical Additives for Sodium Permanganate to Decompose Tetraphenylborate

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

A series of non-rad tests will be performed to study the oxidative destruction of glycolate and/or tetraphenylborate containing solutions.

Rev. 2 A series of tests will be performed to study sodium permanganate to decompose tetraphenylborate. Changes will include extension to the activity end date, new project contact, and updated scope.
