

Proposed Action Title: Road 5 Milling, Paving, and Striping

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Road 5 Milling, Paving, and Striping. Mill, pave and stripe Road 5 from Road 6 to Road C. Mill 3" of Road 5 and resurface with 1" Open Graded Interlayer (OGI) and 2" of SRS Surface Course (Mix 1). Road will be striped (temporary and permanent) and raised pavement markers installed.
