

Proposed Action Title: N-Area - Propane Tank Purge 711-4N Lead Melter

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

Subcontractor shall remove propane from the Lead Melter Propane Tank at 711-4N so Construction may replace the failed Rego manifold and test PRVs(Pressure Relief Valves) to satisfy Preventative Maintenance (PM) requirements.
