Proposed Action Title: Dissolution of Th, U, Np, Pu, and Am oxides and metals, U and Al alloys, and packaging and cladding materials such as carbon steel, stainless steel, and other metal alloys to study dissolution behavior including dissolution rates and offgas generation.

Program or Field Office: Savannah River Site

Location(s) (City/County/State): Aiken/Aiken County/South Carolina

Proposed Action Description:

SRNL will perform laboratory experimentation to determine the flowsheet parameters necessary to safely and efficiently dissolve used nuclear fuels (UNF) and other associated materials in the H-Canyon facility. Dissolution flowsheets may be developed for Th, U, Np, Pu, and Am oxides and metals, U and Al alloys, and packaging and cladding materials such as carbon steel, stainless steel, and other metal alloys. Both radiological dissolutions with oxides and metals such as Th, U, Np, Pu, and Am and non-radiological dissolutions with packaging and cladding materials such as Al, Fe, stainless steel, and carbon steel metals and alloys will be performed.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.
