

Proposed Action Title: Tritium Inter-Building Fiber Optic Cable Replacement from Building 234-7H to Building 233-H and from Building 234-7H to Building 234-7H to Building 234-7H to Building 233-H.

Proposed Action Description:

This generic EEC describes the environmental impact of the activities generated by MT-TRI-2024-00010, MT-TRI-2024-00011, MT-TRI-2024-00013, and MT-TRI-2024-00014. This generic EEC describes the design, installation, tests for the four new fiber optic cable (FOC) runs and change to Out Of Service (OOS) status for the four existing new fiber optic cable runs. New and existing paths will be used. This Project will serve classified and unclassified DCS and data systems. The new runs are from Building 234-7H to Building 234-7H to Building 233-H, from Building 233-H, from Building 248-H to Building 264-H, and from Building 264-H to Building 233-H.
