ORDER GRANTING BLANKET AUTHORIZATION  
TO EXPORT NATURAL GAS TO MEXICO

DOE/FECM ORDER NO. 5280

APRIL 14, 2025

## I. DESCRIPTION OF REQUEST

On March 5, 2025, Enestas, S. de R.L. de C.V. (Enestas) filed an application with the Office of Fossil Energy and Carbon Management (FECM) of the Department of Energy (DOE) requesting blanket authorization under section 3 of the Natural Gas Act (NGA)<sup>1</sup> for the authority summarized in the list below. The applicant requests the authorization for a two-year term beginning on May 26, 2025.<sup>2</sup> Enestas is a Mexico limited liability company with its principal place of business in Mexico City, Distrito Federal, Mexico.

1. Export up to 7.2 billion cubic feet (Bcf) of natural gas to Mexico by pipeline at any point on the border between the United States and Mexico

## II. FINDING

DOE has evaluated the application to determine if the proposed import and/or export arrangement meets the public interest requirement of section 3 of the NGA, as amended by section 201 of the Energy Policy Act of 1992 (Pub. L. 102-486). Under NGA section 3(c), imports and exports of natural gas, including liquefied natural gas (LNG), from or to any country with which the United States has entered into a free trade agreement (FTA) requiring national treatment for trade in natural gas and the import of LNG from other international sources are deemed to be consistent with the public interest.<sup>3</sup> DOE must grant such applications without modification or delay.<sup>4</sup> The authorization sought by Enestas meets the NGA section 3(c) criteria, and, therefore, is deemed to be consistent with the public interest.

1. Authority to regulate the imports and exports of natural gas, including liquefied natural gas, under section 3 of the NGA (15 U.S.C. § 717b) has been delegated to the Assistant Secretary for FECM in Redelegation Order No. S4-DEL-FE1-2023, issued on April 10, 2023.

2. Enestas' blanket authorization, granted in DOE/FECM Order Nos. 5003 and 5003-A, extends through May 25, 2025.

**ORDER**

Pursuant to section 3(c) of the NGA, it is ordered that:

A. Enestas is authorized for the activity described below. This authorization shall be effective for a two-year term beginning on May 26, 2025, and extending through May 25, 2027.

1. Export up to 7.2 Bcf of natural gas to Mexico by pipeline at any point on the border between the United States and Mexico

B. **Monthly Reports:** With respect to the imports and/or exports authorized by this Order, Enestas shall file with the Office of Regulation, Analysis, and Engagement, within 30 days following the last day of each calendar month, a report on Form FE-746R indicating whether imports and/or exports have been made. Monthly reports must be filed whether or not initial deliveries have begun. If no imports and/or exports have been made, a report of "no activity" for that month must be filed. If imports and/or exports have occurred, the report must provide the information specified for each applicable activity and mode of transportation, as set forth in the Guidelines for Filing Monthly Reports. C. The first monthly report required by this Order is due not later than June 30, 2025, and should cover the reporting period from May 26, 2025 through May 31, 2025.
