WEATHERIZATION PROGRAM NOTICE IIJA-7 Revised ISSUED DATE: April 14, 2025

UPDATE: References to the Bipartisan Infrastructure Law (BIL) have been updated to Infrastructure Investment and Jobs Act (IIJA).

EXECUTIVE SUMMARY: Weatherization Program Notice (WPN) IIJA-7 addresses critical updates to the Weatherization Assistance Program (WAP) Formula Infrastructure Investment and Jobs Act (IIJA) grant program by:

- 1. Extending the grant period of performance to June 30, 2029.
- 2. Extending the Average Cost Per Unit (ACPU) to an average over seven years to align with the new grant period of performance.
- 3. Notifying Grantees that the remaining 50% of IIJA funding will be obligated while retaining the requirements to meet the original milestones outlined in WPN IIJA-1.
- 4. Provides the process for obtaining Automated Standard Application for Payments (ASAP) agency approval, for Grantees who have not demonstrated the milestones outlined in WPN IIIA-1

SUBJECT: WAP Infrastructure Investment and Jobs Act Award Extension and Obligating Remaining 50% of Funding

APPLICABLE TO: WAP Grantee Program Managers and Financial Staff

PURPOSE: To provide updated information regarding IIJA WAP Formula grant period of performance, obligation of remaining 50% of IIJA funds, and information on calculating the ACPU for IIJA grants.

SUPERSEDES: This WPN supersedes WPN IIJA-5, Section: Average Cost Per Unit

SCOPE: The provisions of this Guidance apply to all Grantees awarded financial assistance under DOE WAP IIJA grants.

LEGAL AUTHORITY: Title IV, Energy Conservation and Production Act (ECPA), as amended, authorizes the Department to administer the WAP (42 U.S.C. § 6861, et. seq.). All grant awards made under this Program shall comply with applicable law and regulations including, but not limited to, the WAP regulations contained in the Code of Federal Regulations (CFR) at 10 CFR 440, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards 2 CFR 200, and the Infrastructure Investment and Jobs Act Public Law 117-58.

BACKGROUND: On November 15, 2021, the President signed into law the Infrastructure Investment and Jobs Act (Public Law 117-58), also referred to as the Infrastructure Investment and Jobs Act (IIJA), which provides \$3.5 billion in funding for Weatherization.

SEC. 40551. WEATHERIZATION ASSISTANCE PROGRAM

(a) AUTHORIZATION OF APPROPRIATIONS—There is authorized to be appropriated to the Secretary for the weatherization assistance program established under part A of title IV of the Energy Conservation and Production Act (42 U.S.C. 6861 et seq.) \$3,500,000,000 for fiscal year 2022, to remain available until expended.

The U.S. Department of Energy (DOE) WAP issued <u>Infrastructure Investment and Jobs Act</u> (<u>IIJA</u>) <u>Grants for the Weatherization Assistance Program</u> on March 30, 2022, which included a framework for the release of IIJA funds. On July 9, 2024, WAP issued <u>Weatherization</u> <u>Memorandum 131: Requirements to Request Remaining 50% of Obligated Funds Under the Infrastructure Investment and Jobs Act.</u>

This Weatherization Program Notice is issued to notify Grantees that DOE will be extending the period of performance for WAP IIJA formula grant awards to June 30, 2029. As outlined in Public Law 117-58, Congress intended for funds to remain available until expended and DOE is aware of the extenuating challenges faced by the network to ramp up service delivery. Furthermore, DOE will obligate the remaining 50% of IIJA funding, while retaining the requirements to meet the original milestones outlined in WPN IIJA-1. To do this, Grantees who have not met the milestones and are not currently on ASAP approval, will be required to comply with ASAP agency approval process for their IIJA award as outlined in the details below.

GUIDANCE:

Grant Period of Performance:

The Period of Performance for WAP IIJA formula Grantees will be extended to June 30, 2029.

Average Cost Per Unit (ACPU):

For expenditure limits and renewable energy measures, IIJA funded grants will now follow a 7-year average of annual ACPU limits from Program Years (PY) 2022-2028. DOE will track

expenditures, production, and the ACPU throughout the life of the grant, but the ACPU for the award will be evaluated based on the final average ACPU. How averages will be calculated is outlined below.

Note: IIJA does not provide Weatherization Readiness Funds (WRF), therefore if Grantees allow WRF dollars to be spent on IIJA projects they are excluded from the ACPU.

Obligation of Final 50% of IIJA funding and requirement for ASAP agency approval until WPN IIJA-1 milestones have been demonstrated:

DOE will modify WAP IIJA grant awards to obligate final 50% tranche of IIJA funding. However, DOE retains the original requirement for Grantees to meet milestones outlined in WPN IIJA-1 to draw the final 50% of IIJA funding. To ensure Grantees do not draw against more than the first 50% of IIJA funds before meeting the IIJA milestones, DOE is placing Grantees on ASAP Agency Approval.

DOE has identified three group types of Grantees and how this new process will impact each group type:

Туре	Grantee ASAP Agency Approval Invoicing Status	Process
1	Grantees who have demonstrated achievement of the seven milestones outlined in IIJA-1, submitted documentation and received approval by DOE to release the remaining 50% of funding.	No ASAP agency approval will be required.
2	Grantees currently on ASAP approval because of identified risk and compliance factors.	Continue to follow the current ASAP approval process, which may include providing detailed back up documentation.
3	Grantees who have NOT met the seven milestones and are NOT currently on ASAP approval because of identified risk factors.	Follow the ASAP agency approval process as outlined in this WPN and WAP IIJA Payment Request Instructions- Attachment 1.

This ASAP approval process is outlined in the WAP IIJA Payment Request Instructions (Attachment 1) and will require Grantees to:

- Submit the required materials to your Project Officer **before** submitting a request for payment in ASAP:
 - Standard Form (SF)-270 "Request for Advance or Reimbursement" (Attachment
 2) and,
 - WAP IIJA Agency Approval Template (Attachment 3) which aligns with Grantee PAGE budget. The spreadsheet is used to document any spending that is summarized in the SF-270 form.
- Only Tab 1 "Draw Request" is needed for Type 3 Grantees as defined in the table above.

To ensure expediency with DOE invoice approvals, please only send the documentation requested.

WAP encourages Grantees to review Term 30 Payment Procedures outlined in their IIJA Special Terms and Conditions.

When the Grantee has met or will soon meet the milestones in <u>WPN IIJA-1</u>, the Grantees should reach out to their Project Officer and submit documentation to initiate the milestone review process outlined in <u>WAP Memo 131</u>. Grantees will be unable to receive payment requests in

ASAP that exceed the first 50% of IIJA funds until the Grantee has met the milestones outlined in WPN IIJA-1.

Once all IIJA milestones are met, the Project Officer has reviewed the Grantee's plan modification documentation, and the Contracting Officer has approved the modification, the ASAP approval condition will be lifted from the grant award.
