Dear Ms. Sweeney:

Sabine Pass Liquefaction, LLC ("SPL") and Sabine Pass Liquefaction Stage V, LLC (together with SPL, "Sabine Pass") hereby submit¹ for filing under seal, a non-redacted copy of the Gas Supply Agreement (the "Contract") entered into by Cheniere Marketing, LLC ("Cheniere Marketing") on May 27, 2025 with Cannat Energy Inc. ("Counterparty"). Under the Contract, Counterparty will sell and Cheniere Marketing will purchase natural gas on a long-term basis. Sabine Pass intends to liquefy the natural gas purchased from Counterparty at the Sabine Pass LNG facilities.

Sabine Pass is also filing herewith a public summary of the major provisions of the Contract. This filing is being submitted in accordance with Department of Energy, Office of Fossil Energy and Carbon Management ("DOE/FECM") Order Nos. 2833, 2961-A, 3306, 3307, 3384, 3595, 3669, 3792, 4520, 4800, and 5181 (each as may have been amended).² Sabine Pass hereby
