




PORTS Integrated Project Portfolio


X-333 Demolition Start: Transite Removal

D&D and OSMS Contracts Transition





Procurement Strategy

- Parallel procurement to transfer operations scope under Fluor-BWXT Portsmouth, LLC (FBP) Decontamination and Decommissioning (D&D) contract to the new Operations and Site Mission Support (OSMS) contract
- Concurrent transitions of both the future PORTS D&D and OSMS contracts to ensure continuity of service due to scope transfer





Work Scope Transition

- Allows new PORTS D&D Contractor to focus on End State completion
- Scope to be transferred includes
 - Utilities
 - Emergency Management
 - Physical Security
 - Uranium transfers
 - Nuclear Material Control and Accountability





D&D Scope

The completion of the Portsmouth D&D project including –

- Demolition and disposal of Gaseous Diffusion Plant (GDP) facilities, process equipment, related process buildings, and other ancillary GDP facilities
- Remediation of contaminated soils and groundwater
- Disposition of uranium material





D&D Contract

- The new PORTS D&D contract was awarded to Southern Ohio Cleanup Company, LLC (SOCCo) of Aiken, South Carolina on July 13, 2023
- SOCCo is a newly formed limited liability company made up of:
 - Amentum Environment and Energy, Inc.
 - Fluor Federal Services, Inc.
 - Cavendish Nuclear (USA) Inc.
- Maximum value of up to \$5.87 billion, over the 10-year ordering period, with work not to exceed a maximum of 15 years
- Promotes robust community commitment and engagement
 - Site Reindustrialization
 - Community Commitment Plan
 - 5% preference for small business subcontract proposals from regional small businesses





OSMS Scope

- Depleted Uranium Hexafluoride (DUF6) conversion facilities at Portsmouth and Paducah
- UF6 transfer/repackaging processes at Portsmouth
- Cylinder surveillance and maintenance services
- Support disposition of UOx (i.e., shipping programs, procedures, plans)
- Protective (guard) force
- Emergency management and fire protection services
- Waste management facilities
- Utility services






OSMS Contract

- The new PORTS OSMS contract was awarded to Mission Conversion Services Alliance LLC (MCSA) of Oak Ridge, Tennessee in December 2024
- MCSA is a newly formed limited liability company made up of:
 - Atkins Nuclear Secured, LLC
 - Westinghouse Government Services, LLC
 - Jacobs Technology, Inc.
- Contract value is \$2.3B over a 10 year and 4-month period of performance.
- Promotes robust community commitment and engagement
 - Community commitment plan
 - Preference for small business subcontract proposals from Portsmouth/Paducah regional small businesses
