**Motion to Intervene of Public Citizen, Inc.**

New Fortress Energy operates the Altamira LNG export terminal on Mexico's east coast on the Gulf of Mexico. We move to intervene in Altamira's application to extend its export term through December 31, 2050 for its existing non-free trade agreement export authorization.<sup>1</sup>

Public Citizen hereby intervenes in this proceeding. Established in 1971, Public Citizen, Inc. is a national, not-for-profit, non-partisan, research and advocacy organization representing the interests of American household consumers. Public Citizen is active before the U.S. Department of Energy seeking to ensure that applications to export U.S. natural gas are consistent with the public interest. Extending Altamira's authorization to export U.S. natural gas all the way out to 2050 may come at the expense of higher domestic energy prices for Americans and decrease sufficient availability of domestic gas supply, thereby raising concerns whether the request is consistent with the public interest. Our interests in this proceeding are unique, and cannot be represented by any other party. Financial details about our organization are on our web site.<sup>2</sup>
