## **Description of the Proposed Action:**

Western Area Power Administration, Sierra Nevada Region (WAPA) is responsible for the operation and maintenance of several federally owned and operated transmission lines throughout California. Part of this responsibility includes ensuring WAPA maintains reliable access to transmission towers and other facilities to comply with the National Electric Safety Code, Western States Coordinating Council, and WAPA directives for protecting human safety and maintaining the reliable operation of the transmission system.

WAPA is proposing to demolish and dispose of an existing unused storage building, located at the Elverta Substation. This building is known as Building 10 and is approximately 300 square feet in area. The demolition and removal will take place within the Elverta Substation, fee-owned and operated by WAPA. This work will be done using in-house labor and government-owned equipment such as a forklift and mini-excavator. No ground disturbance is expected for this project, as the concrete foundation/platform will remain in place. All debris associated with this demolition project will be removed and transported to local certified landfills that are required to accept these type of building materials.

#### Findings:

WAPA follows the regulations at 40 C.F.R. Parts 1500-1508, in addition to the Department of Energy's (DOE) regulations implementing National Environmental Policy Act (NEPA) at 10 C.F.R. Part 1021 to meet the agency's obligations under NEPA, 42 U.S.C. §§ 4321 et seq. In accordance with Section 1021.410(b) DOE's NEPA Regulations (57 FR 15144, Apr. 24, 1992, as amended at 61 FR 36221-36243, Jul. 9, 1996; 61 FR 64608, Dec. 6, 1996, 76 FR 63764, Nov. 14, 2011), WAPA has determined that the proposed action:

- (1) fits within a class of actions listed in Appendix B of 10 CFR 1021, Subpart D (see attached Environmental Checklist);
- (2) does not present any extraordinary circumstances that may affect the significance of the environmental effects of the proposal; and
- (3) has not been segmented to meet the definition of a categorical exclusion.

Based on these determinations, WAPA finds that the proposed action is categorically excluded from further NEPA review.

# **Categorical Exclusion Environmental Checklist**

**Proposed Action:** Elverta Building 10 Demolition and Disposal

#### **Project Site Description**

This Project lies within a rural area of Sacramento County (Township 10N, Range 05E, Section 19) on the southwest corner of Elverta Road and El Rio Avenue in Elverta, California at the WAPA Elverta Substation. The area surrounding the project site is relatively flat, open, and comprises lands zoned as agricultural, agricultural reserve, and agricultural residential.

Work will occur within the WAPA Elverta Substation, Elverta Maintenance Facility, and the access road connecting them. All debris associated with this demolition project will be removed and transported to local certified landfills that are permitted to accept these type of building materials. WAPA has verified that no aesbestos or lead paint is present and has not discovered any other hazardous materials associated with the building materials.

	No residences are found within or near the project area. Noise from this project is typical of routine equipment operation at the Elverta substatoin and maintenance facility, will be limited in duration, and will occur during daytime hours.
