Proposed Action Title: Niron Magnetics, Inc. -- Pilot Production for Commercial Sampling of Rare-Earth-Free Iron Nitride Permanent Magnets

## **Proposed Action Description:**

Funding will support the project team's small-scale research and development of an Iron Nitride-based Clean Earth Magnet(TM), made from abundant commodity raw materials. Specifically, the project team will (1) manufacture magnets for use in prototype construction and testing, (2) construct facility for large-scale magnet manufacture, and (3) test and verify magnet function and manufacturing scale capability. If successful, this project will result in a less expensive, domestically manufacturable, powerful magnet solution for the clean economy with minimized supply chain risk and a significantly reduced environmental footprint.

Project activities will be conducted at existing facilities at Niron Magnetics, Inc. (Minneapolis, MN), Cerion Nanomaterials, LLC (Rochester, New York), and Forge Nano, Inc. (Thornton, CO) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project.
