Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (a) Actions to conserve energy or water, demonstrate potential energy or water conservation, and promote energy efficiency that would not

have the potential to cause significant changes in the indoor or outdoor concentrations of potentially harmful substances. These actions may

(such as traffic signal control systems, car navigation, speed cameras, and automatic plate number recognition);

development of energy-efficient manufacturing, industrial, or building practices; and small-scale energy efficiency

and conservation research and development and small-scale pilot projects. Covered actions include building renovations or new structures,

provided that they occur in a previously disturbed or developed area. Covered actions could involve commercial, residential, agricultural,

academic, institutional, or industrial sectors. Covered actions do not include rulemakings, standardsettings, or proposed DOE legislation,

except for those actions listed in B5.1(b) of this appendix.

- (b) Covered actions include rulemakings that establish energy conservation standards for consumer products and industrial equipment. provided that the actions would not:
  - Have the potential to cause a significant change in manufacturing infrastructure (such as construction of new manufacturing plants with considerable associated ground disturbance);
  - involve significant unresolved conflicts concerning alternative uses of available resources (such as rare or limited raw materials):
  - have the potential to result in a significant increase in the disposal of materials posing significant risks to human health and the environment (such as RCRA hazardous wastes); or

### Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the City of New Orleans, LA through the Local Government Energy Program: Communities Sparking Investment in Transformative Energy (C-SITE) Funding Opportunity Announcement (FOA) Number: DE-FOA-0003229. Through the C-SITE program, the City of New Orleans Office of Resilience and Sustainability (ORS) will work with community partners to grow the city's fleet of shared, electric bikes and train a new generation of e-bike mechanics over a three-year period.

This NEPA Determination (ND) only applies to Budget Period One (BP1) Task 1.0 through Subtask 4.3 activities. The DOE will complete the NEPA review for BP1 Subtask 4.4 and Task 5.0, BP2, and BP3 when sufficient information is available to conduct a meaningful review. Sufficient information would include the engineering/design plans at each bike station location as well as detailed information such as size, scale, and dimensions of bike stations and equipment.

The activities covered by this ND are: executing partner sub-agreements, establish an e-bike mechanic training and bicycling safety curriculum, enroll and train 10-30 students in the e-bike mechanic training program, obtain and deploy new e-bikes (825 cumulatively), and background research to find the best locations for 12 bike stations through a collaborative planning process with the Regional Planning Commission, ORS, and Department of Public Works.

DOE is aware of the November 12, 2024, decision in Marin Audubon Society v. FAA, No. 23-1067 (D.C. Cir. Nov. 12, 2024). To the extent that a court may conclude that the Council on Environmental Quality (CEQ) regulations implementing NEPA are not judicially enforceable or binding on this agency action, EERE has nonetheless elected to follow those regulations at 40 C.F.R. Parts 1500-1508, in addition to DOE's procedures/regulations implementing NEPA at 10 C.F.R. Part 1021, to meet the agency's obligations under NEPA, 42 U.S.C. §§ 4321 et seq.

- 2. The City of New Orleans is responsible for reviewing the online NEPA and Historic Preservation training at www.energy.gov/node/4816816 and contacting GONEPA@ee.doe.gov with any NEPA or general historic preservation questions.
- 3. The City of New Orleans is required to submit an annual historic preservation report. If you have any questions about completing the annual historic preservation report, please contact historic preservation@ee.doe.gov and include your DOE Project Officer on the email.

# Notes:

The City of New Orleans must review and adhere to the terms and restrictions of the DOE-executed Historic Preservation Programmatic Agreement with the state of Louisiana to ensure protection of cultural resources. The recipient must have satisfied their Section 106 of the National Historic Preservation Act requirements before the issuance of the final ND for the remaining budget periods and tasks.

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

A portion of the proposed action is categorically excluded from further NEPA review. The NEPA Provision identifies Topic Areas, Budget Periods, tasks, and/or subtasks that are subject to additional NEPA review.
