## **Proposed Action or Project Description:**

The proposed action includes Information Gathering, Analysis, and Dissemination; and the performance of geotechnical investigation and percolation testing of the soil within the proposed action location. Proposed activities include the use of a drill rig with a hollow stem auger and potential use of a mini-excavator to obtain soil samples; and the potential to install piezometers, or create a test pit in which percolation testing may be performed.
