There is also a profound international responsibility here. These waters are protected under treaties and laws meant to safeguard marine mammals and endangered species, such as the Marine Mammal Protection Act (MMPA), the Endangered Species Act (ESA), and regional agreements protecting marine biodiversity. Approving further delay or extending the project's timeline could undermine commitments to protect these vital ecosystems and counter the global efforts to preserve marine species . yet I fear that the pursuit of short-term gains might overshadow our moral and legal obligations to protect these precious ecosystems.

Please, I implore you to reconsider granting any extensions or approvals for this project. It is not just about economics or energy; it's about the kind of world we want to leave behind for future generations. We have the power—and the moral obligation—to halt or significantly delay this project before irreversible harm is done.
