On May 1, 2025, Louisiana LNG Infrastructure LLC (“Louisiana LNG”) submitted a Statement of Change in Control (“Statement”) to the U.S. Department of Energy (“DOE”), Office of Fossil Energy and Carbon Management (“DOE/FECM”).¹ In the Statement, Louisiana LNG provided notice of an anticipated change in its upstream ownership (“Proposed Transaction”), consistent with DOE’s Change in Control Procedures,² and indicated that it would notify DOE/FECM after close of the Proposed Transaction. Louisiana LNG herein provides notice that on June 25, 2025, Woodside Energy Group Ltd. announced that the Proposed Transaction closed.³
