Long-Term Supply Contract

Dear Ms. Sweeney:

Sabine Pass Liquefaction, LLC ("Sabine Pass") hereby submits¹ for filing under seal, a non-redacted copy of the NAESB Base Contract for Sale and Purchase of Natural Gas (as may have been amended from time to time, the "Base Contract") and the Transaction Confirmation ("Confirmation"), entered into by Sabine Pass on March 4, 2015 and July 18, 2025 (respectively) with Sequent Energy Management LLC, successor-in-interest to Williams Energy Resources with respect to the Base Contract ("Counterparty"). Under the Base Contract and Confirmation, Counterparty will sell and Sabine Pass will purchase natural gas on a long-term basis. Sabine Pass intends to liquefy the natural gas purchased from Counterparty at the Sabine Pass LNG facilities.

Sabine Pass is also filing herewith a public summary of the major provisions of the Base Contract and Confirmation. This filing is being submitted in accordance with Department of Energy, Office of Fossil Energy and Carbon Management ("DOE/FECM") Order Nos. 2833, 2961-A, 3306, 3307, 3384, 3595, 3669, 3792, 4520 & 4800 (each as may have been amended).² Sabine Pass hereby requests confidential treatment of the Base Contract and
