Proposed Action Title: Ancillary Service, Transmission Losses, Unreserved Use Penalties, and Energy Imbalance Markets Rate Extension - Rate Order WAPA-222

Program or Field Office: Western Area Power Administration - Desert Southwest Region

Location(s) (City/County/State): Arizona, California, and Nevada

Proposed Action Description:

The Desert Southwest Region (DSW) of the Western Area Power Administration proposes to extend the existing Ancillary Service, Transmission Losses, Unreserved Use Penalties, and Energy Imbalance Market rates for the Western Area Lower Colorado Balancing Authority through September 30, 2031. The existing formula rates expire on September 30, 2026.

DSW is using a rate extension process and, in accordance with 10 CFR 903.23, all interested parties will have an opportunity to provide comments during a consultation and comment period. DSW will review and consider all timely public comments and make amendments or adjustments to the proposal as appropriate.
