Pursuant to the above-referenced Orders, Sabine Pass Liquefaction, LLC ("Sabine Pass") and Sabine Pass Liquefaction Stage V, LLC ("Sabine Pass Stage V"), herein submit the semi-annual report for March 1, 2025 through August 31, 2025. This report includes a list of the items which have been filed during the reporting period relating to long-term contracts associated with the long-term export of LNG from the Sabine Pass LNG Terminal, as well as long-term gas supply contracts. Sabine Pass and Sabine Pass Stage V's application to site, construct, and operate the Stage 5 Project expansion remains pending before the Federal Energy Regulatory Commission in Docket No. CP24-75-001. Therefore, there is no Stage 5 Project construction activity to report for this reporting period.

- Sabine Pass and Sabine Pass Stage V submitted the following new long-term contract(s) associated with the long-term export of LNG from the Sabine Pass LNG Terminal during the reporting period:
 - On July 31, 2025, Cheniere Marketing, LLC entered into a long-term sale and purchase agreement with Jera Co., Inc.
- Sabine Pass submitted the following new long-term gas supply contract(s) during the reporting period:
 - On July 18, 2025, Sabine Pass entered into a Transaction Confirmation with Sequent Energy Management LLC, governed by that certain NAESB Base Contract for Sale and Purchase of Natural Gas dated March 4, 2015, for an aggregated annual contract quantity of approximately 40,000,000 MMBtus.

- On March 6, 2025, Sabine Pass entered into a Transaction Confirmation with Expand Energy Marketing LLC, governed by that certain NAESB Base Contract for Sale and Purchase of Natural Gas dated November 1, 2013, for an aggregated annual contract quantity of approximately 18,000,000 MMBtus
- Sabine Pass and Sabine Pass Stage V submitted the following new long-term gas supply contract(s) during the reporting period:
 - On May 27, 2025, Cheniere Marketing, LLC entered into a Gas Supply Agreement with Cannat Energy Inc. for an annual contract quantity of approximately 50,000,000 MMBtu.
