	Title to and risk of loss will occur at vessel loading flange or when the product passes the custody measurement point for pipelines, trucks, inter-and intra-terminal transfers, as specified in the DOE Northeast Home Heating Oil Distribution Plan. 4.	All product purchased under this solicitation is subject to the terms of the DOE Northeast Home Heating Oil Distribution Plan. The Distribution Plan guarantees product will be delivered FOB across the contractor's docks or truck racks in a reasonable time frame.
