Proposed Action Description
<p>LM is proposing to fund and complete an erosion risk flume study at the Colorado State University (CSU) Hydraulics Laboratory (HL) in Fort Collins, Colorado. To execute this study, LM proposes to collect and transport soil from various LM managed and future LM managed (transition) sites to CSU. Flume studies are being conducted to inform current uncertainties related to long-term erosion resistance of alternative disposal cell covers, assist in determining proposed enhancements to existing disposal cell covers, and support the development of methods to quantify erosional risk at disposal cells. The results would inform long-term management strategies at LM disposal sites.</p> <p>Soil collected to aid in this study would be sourced from the Crescent Junction, Utah, Disposal Site located one-mile northeast of the junction of U.S. Highway 191 and Interstate 70 in Crescent Junction, Grand County, Utah. Actions proposed include loading approximately 80 cubic yards of existing stockpiled soils onto trucks and transporting the material to CSU HL for erosion flume studies.</p>
