Proposed Action Description

DOE-LM is proposing to conduct routine long-term surveillance and maintenance (LTS&M) actions at the Split Rock, Wyoming, Disposal Site located in Fremont County approximately two miles northeast of Jeffrey City, Wyoming.

Proposed actions would include inspections, groundwater and surface water monitoring, site characterization and resource assessments, vegetation control, scientific studies and research, and routine maintenance of site features, groundwater monitoring wells, and associated infrastructure. These proposed routine LTS&M actions would be performed to satisfy requirements outlined in the site's Long-Term Surveillance Plan, which explains how DOE-LM fulfills general license requirements as the long-term custodian of the site in a manner that is protective of human health and the environment.
