Proposed Action Title: PowerN, Inc. -- CPMS: A Digital Platform for Managing High Precision Construction, Design Integration, and Accelerated Licensing of Energy Facilities

Proposed Action Description:

Funding will support the project's small-scale research and development activities to continue refining a virtual environment platform that can support modular construction of nuclear power plants. This project was initially developed by North Carolina State University and PowerN, Inc. under an ARPA-E-funded project entitled "A Data-driven Approach to High Precision Construction and Reduced Overnight Cost and Schedule" and reviewed in a NEPA determination signed on August 7, 2019. Specifically, the project team will further develop, test, and refine a virtual environment platform that can model and simulate construction performance using as-planned Building Information Modeling (BIM) and as-built point clouds of off-site components and main structure, a virtual assembly based on geometry, construction sequence, and logic, by employing automated data collection solutions for capturing as-built conditions of pre-fabricated components at off-site facilities using robotics and visual sensors. If successful, the project team will complete the final software suite that will reduce the cost and schedule uncertainty of nuclear construction projects by leveraging virtual reality, automated inspection, and work flow optimization, ultimately enabling safer and more cost-effective design of low-carbon emitting power sources.

Project activities will be conducted at an existing facility at PowerN, Inc (Raleigh, NC) designed for the applicable activities. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to existing facilities to accommodate the proposed work.
