SECOND AMENDED PROGRAMMATIC NEPA DETERMINATION (See attached original and First Amended Determinations, dated August 1, 2025 and February 18, 2026, respectively). The Technologies to Emend and Obviate SYnthetic Nitrogen’s Toll on Emissions (TEOSYNTE) program supports projects that focus on plant and microbial bio-design strategies that reduce the need to apply synthetic nitrogen fertilizer on corn and sorghum fields while maintaining crop yields. If successful, TEOSYNTE projects would lower costs to farmers by reducing the use of synthetic fertilizer, reduce imports of foreign synthetic nitrogen fertilizer by lowering nitrogen fertilizer used in U.S. agriculture by 27%, lower the demand for natural gas feedstock for fertilizer production, and improve the efficiency of ethanol production from bioenergy crops, thereby increasing U.S. energy security.

The TEOSYNTE Program is composed of 9 small-scale research and development projects that will be conducted by universities, large and small businesses, and national laboratories. This Second Amended Determination adds 1 project to the original and First Amended Determinations (see Attachment A). All 7 projects covered by this Determination fit within the class of actions identified under the DOE Categorical Exclusions identified below. This assessment was based on a review of the proposed scope of work and the potential environmental impacts of each project. All project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and Local regulatory requirements. The University of Illinois, Urbana-Champaign has not obtained all necessary permits and approvals for their proposed actions and are prohibited from commencing applicable project work until such permits are obtained. The Technologies to Emend and Obviate SYnthetic Nitrogen’s Toll on Emissions (TEOSYNTE) program supports projects that focus on plant and microbial bio-design strategies that reduce the need to apply synthetic nitrogen fertilizer on corn and sorghum fields while maintaining crop yields.
