Proposed Action Title: ChemFinity Technologies, Inc. -- Tunable Porous Polymer Networks with Unprecedented Efficiency in Recovering Critical Metals

Program or Field Office: Advanced Research Projects Agency - Energy

Proposed Action Description:

Funding will support the project's small-scale research and development of new processes to recycle critical minerals from e-waste, spent catalytic converters, and other sources by leveraging ChemFinity's porous sorbent material technology. Specifically, the project team will (1) fabricate sorbents to capture metals such as platinum and neodymium, (2) verify sorbent function under high-capacity conditions, and (3) prepare forecasts, analysis, and projections of the project's large-scale applications. If successful, this project would result in sorbent technology in support of energy efficiency and decarbonization in critical mineral processing while also creating new pathways to secure domestic critical mineral supplies.

Project activities will be conducted at an existing facility at ChemFinity Technologies, Inc. (Brooklyn, NY). Project tasks fit within the class of actions identified under the DOE Categorical Exclusions identified below. This assessment was based on a review of the proposed scope of work and the potential environmental impact of the project. Project tasks will be conducted in accordance with established safety and materials/waste management protocols and pursuant to applicable Federal, State, and local regulatory requirements. No modifications will be made to the existing facilities to accommodate the proposed work.
