PRIVILEGED AND CONFIDENTIAL Submission of Contract
and Summary of Major Provisions of Contract for Public Posting

Dear Ms. Sweeney:

Venture Global CP2 LNG, LLC (“CP2 LNG”) was granted long-term, multi-contract authority to export liquefied natural gas (“LNG”) to (1) nations with which the United States has not entered into a Free Trade Agreement (“FTA”) requiring the national treatment of natural gas in Order No. 5264-A issued in FE Docket No. 21-131-LNG on October 21, 2025, and (2) FTA nations in Order No. 4812 in the same docket on April 22, 2022. Ordering Paragraph F(ii) of Order No. 5264-A and Ordering Paragraph (D)(ii) of Order No. 4812 require CP2 LNG to file a non-redacted copy of all executed long-term contracts associated with the long-term supply of natural gas to its Project within thirty days of contract execution. If a contract is filed under seal and subject to a claim of confidentiality or privilege, CP2 LNG also must file for public posting a summary of the non-proprietary, major provisions of the contract.

On July 16, 2026, CP2 LNG entered into a Transaction Confirmation with Trafigura Trading LLC (“Trafigura”) pursuant to a previously executed Base Contract for Sale and Purchase of Natural Gas under which CP2 LNG will purchase natural gas on a long-term basis from Trafigura.

This natural gas supply contract is highly confidential and contains commercially valuable and proprietary information, the disclosure of which would cause competitive and financial harm to the parties to the contract. Accordingly, consistent with the requirements of its export
