Proposed Action or Project Description: American Recovery and Reinvestment Act:

1) Create financial incentive program to provide grants to non-profits, private sector and residents for energy saving retrofits and energy alternatives, 2) install retrofits at city facilities including lighting replacement/upgrade, controls and programmable thermostats, weatherstripping/caulking, HVAC systems and duct work, and 3) promote ride sharing program.
