SUBJECT: Procurement Evaluation and Re-Engineering Team and

Establishment of a 5-Year Cycle with Corresponding Schedule

As you are aware, the Procurement Evaluation and Re-Engineering Team (PERT) has a proven track record within the Department of Energy (DOE) complex for effectively reviewing contractor purchasing systems on Management and Operating contracts.

The PERT program is mission essential. Federal Acquisition Regulation (FAR) 44.302(b) requires Contracting Officers to make an assessment every three years of the need for a review of a contractor's purchasing system; with reduced funding and budget levels, it is considered the most economical way to fulfill the requirements of FAR 44.302(b). The alternative is to contract with independent audit companies for subcontract reviews which can be at a substantially higher cost.

The PERT program also identifies best practices in contractor's purchasing systems and shares this knowledge with all sites. History shows that communication and savings go hand in hand. The success of the PERT program continues to be a collective effort from all of the sites, to include sites funding their staff's participation in the PERT reviews.

The PERT schedule below has been developed to correspond with the new five year review cycle discussed in a previous memorandum. To prevent an overload of reviews being performed in any one year period, some sites will have their next PERT reviews sooner than five years in order for the PERT Program to be on a full five year cycle by 2019. This will spread required travel and associated costs.
