ANNEX I TO IMPLEMENTING ARRANGEMENT NO. 2

BETWEEN PITTSBURGH ENERGY TECHNOLOGY CENTER AND KOREA INSTITUTE OF ENERGY RESEARCH AND KOREA INSTITUTE OF SCIENCE AND TECHNOLOGY

RECITALS:

- The United States Department of Energy (USDOE) and the Ministry of Science and Technology of the Republic of Korea (MOST) have signed an agreement Providing for Cooperative Laboratory Relationship, hereinafter referred to as the USDOE-MOST Agreement
- The Pittsburgh Energy Technology Center (PETC), a facility of the USDOE, the Korea Institute of Energy Research (KIER), and the Korea Institute of Science and Technology (KIST), facilities of MOST, hereinafter referred to as the Parties, perform basic and applied research in fossil energy technology.

SECTION 1

PETC, KIER, and KIST hereby establish a cooperative institutional relationship for the purpose of technical cooperation and collaboration in accordance with the USDOE-MOST Agreement.

SECTION 2

The technical areas and forms of cooperation may include, but are not limited to, the areas and forms of cooperation set out in Article II and Article III of the USDOE-MOST Agreement.

SECTION 3

The exchange of PETC, KIER, and KIST personnel shall be in accordance with Article V of the USDOE-MOST Agreement.

SECTION 4

In accordance with Article IV of the USDOE-MOST Agreement, PETC, KIER and KIST, each shall designate a technical coordinator and a scientific coordinator to carry out the direct implementation of activities. The coordinators shall evaluate the degree of progress of work being conducted under this USDOE-MOST Agreement and shall consider and act upon new proposals for collaboration.

SECTION 5

All questions related to this Annex I shall be settled by mutual agreement of PETC, KIER, and KIST.

SECTION 6

This Annex I shall become effective upon signature by both Parties and upon signature of the USDOE-MOST Agreement, and shall remain in effect for five years. This Annex may be extended by mutual written agreement of the Parties, upon the approval of USDOE and MOST, and it may be terminated at any time by either Party upon six (6) months written notice to the other Party.

SECTION 7

All joint efforts and experiments initiated but not completed at the termination of this MOU may be continued until their completion under the terms of this Annex I and the USDOE-MOST Agreement.
