<u>Proposed Action Title</u>: (0670-2634) Georgia Institute of Technology - Electric Power Generation by a Vertical-Axis Turbine Driven by an Anchored Vortex and Sustained by the Air Layer over Solar-Heated Ground

Program or Field Office: Advanced Research Projects Agency - Energy (ARPA-E)

## Proposed Action Description:

Funding will support efforts to develop and test a SoVgen, a novel device that generates electricity by converting the potential energy of solar-heated air near the ground to kinetic energy in a columnar vortex. Development-based project tasks and controlled testing will be carried out by Georgia Institute of Technology (Atlanta, GA) and the National Renewable Energy Laboratory (Golden, CO) in dedicated university and industrial laboratory and research facilities. Computational and analytical project tasks will be carried out by Georgia Institute of Technology, University of Texas (Austin, TX), United Technologies Research Center (East Hartford, CT), and University of Illinois at Urbana-Champaign (Urbana, IL) in dedicated computing and office facilities. Field testing of prototype SoVgen systems will be conducted by Georgia Institute of Technology in Mesa, AZ and Atlanta, GA and by the National Renewable Energy Laboratory in Golden, CO. Field testing will take place on previously disturbed tracts of land and will not impact endangered, threatened, or other protected species.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
