AMENDMENT OF RECOGNITION

Pursuant to Section 2422.1 of the Regulations of the Federal Labor Relations Authority, a petition was filed seeking to amend the recognition granted to the National Federation of Federal Employees, Local 1141 on January 26, 1965 as the exclusive representative of certain employees of the U.S. Department of Energy, Albany Research Center, Albany, Oregon by changing the designation of the exclusive representative for this existing bargaining unit, from the National Federation of Federal Employees, Local 1141 to the American Federation of Government Employees, Local 1104, AFL-CIO.

On June 10, 1999, I issued a Decision and Order finding that the recognition may be amended as requested. The parties waived their right to file an Application for Review. Pursuant to the authority vested in me as Regional Director,

I ORDER that the recognition granted to the National Federation of Federal Employees, Local 1141 on January 26, 1965, as amended on November 26, 1996 [Amendment of Recognition (Case No. SF-RP-60069)] as the exclusive representative of the following unit of employees:

INCLUDED: All wage grade employees of the Albany Research Center, Albany, Oregon.

EXCLUDED: All general schedule employees; professional employees; management officials; supervisors, and employees described in 5 U.S.C. 7112(b)(2), (3), (4), (6) and (7).

is amended by changing the designation of the exclusive representative from the National Federation of Federal Employees, Local 1141 to the American Federation of Government Employees, Local 1104, AFL-CIO.
