CORRECTED NOTICE OF CORPORATE REORGANIZATION OR CHANGE IN CONTROL AND AMENDMENT OF PENDING APPLICATION TO EXPORT LIQUEFIED NATURAL GAS TO NON-FREE TRADE AGREEMENT COUNTRIES

On May 21, 2015, Louisiana LNG Energy, LLC (LLNG) filed a Notice of Change in Control in the above-captioned docket<sup>1</sup> which, in relevant part, requested approval of an amendment to LLNG's pending application to export liquefied natural gas (LNG) to countries with which the United States does not have a free trade agreement (FTA) requiring national treatment for trade in natural gas, and with which trade is not prohibited by U.S. law or policy (non-FTA countries). The purpose of the Notice of Change in Control was to reflect the acquisition of LLNG by Parallax Enterprises (NOLA) LLC (Parallax NOLA).

On June 8, 2015, the U.S. Department of Energy, Office of Fossil Energy (DOE/FE), issued a Notice and Amendment of Pending Application recognizing LLNG's Notice of Change in Control.<sup>2</sup> DOE/FE's Notice reflected its understanding that LLNG was seeking to amend the

named applicant in the proceeding—from LLNG to Parallax NOLA—due to the corporate reorganization and change in control. Consequently, DOE/FE named Parallax NOLA as the new applicant in the non-FTA export proceeding.

By letter to DOE/FE dated October 2, 2015, however, LLNG notified DOE/FE that it "did not intend through its Notice of Change in Control to change the identity of ... the applicant in the non-FTA proceeding." LLNG further explained:

While Parallax NOLA has acquired all of the outstanding membership interests in LLNG, LLNG will remain .... the applicant in the non-FTA proceeding. The Notice of Change in Control was intended to inform DOE/FE only of a change in LLNG's upstream ownership.<sup>4</sup>

In light of this explanation, we are now correcting DOE/FE's Notice dated June 8, 2015, only to the extent that it recognized Parallax NOLA as the new applicant in this proceeding.

Accordingly, pursuant to DOE/FE's Revised Procedures for a Change in Control<sup>5</sup> and its regulations at 10 C.F.R. § 590.204(a), Louisiana LNG Energy, LLC is hereby reinstated as the applicant in the non-FTA export proceeding pending in FE Docket No. 14-29-LNG. Except as to this correction, DOE/FE's Notice dated June 8, 2015, remains in full force and effect.
