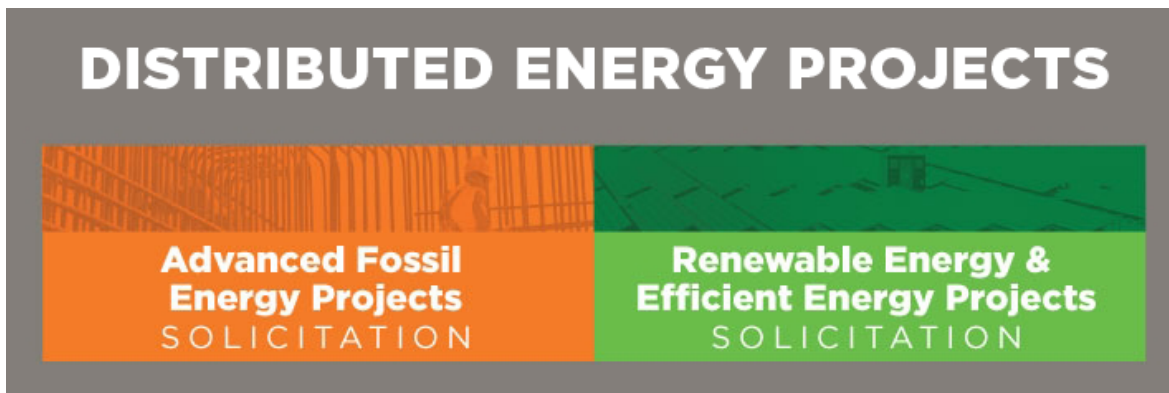

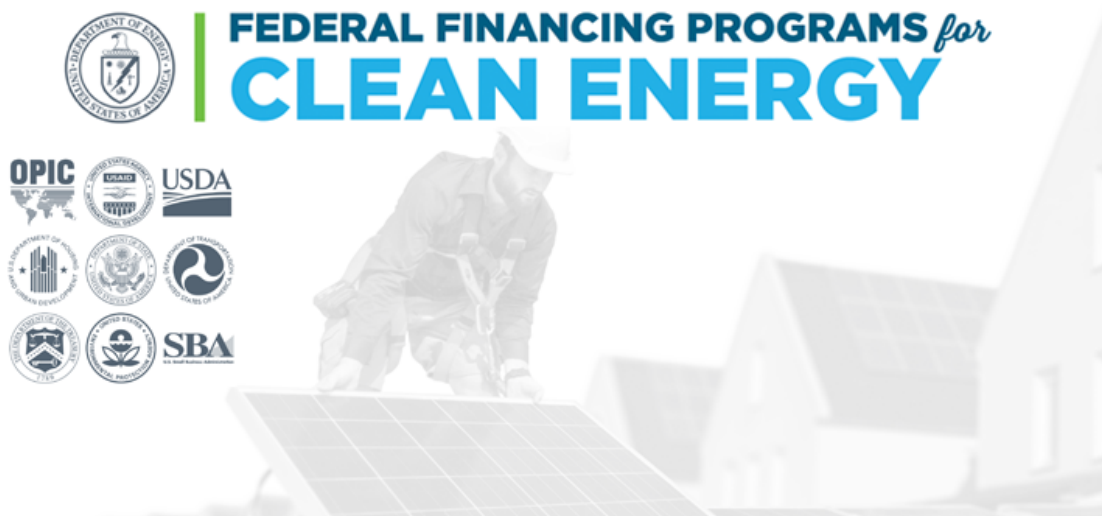

At the beginning of June, Secretary Moniz hosted the 7th Clean Energy Ministerial in San Francisco. It was the first gathering of global energy leaders since last December's climate negotiations in Paris and focused on expanding international collaboration in clean energy research, development, demonstration and deployment to combat climate change, drive economic growth, and help ensure energy security.

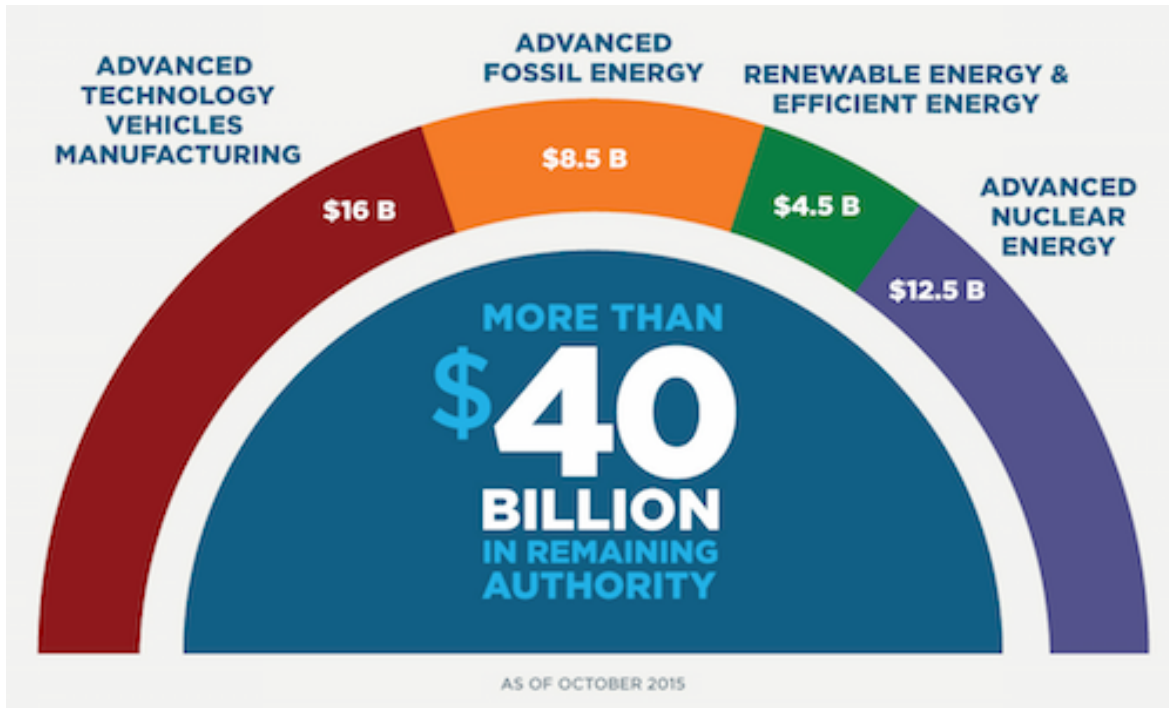
