- Intregrated Approach to Contract/Baseline Alignment


Looking Forward

Guiding Principles

- Deputy Secretary's memorandum of December 13, 2012
 - Improve acquisition planning and contract management thru two primary principles:
 - How the two primary principles are implemented
 - Align contractor interest to the taxpayer interest
 - Structure contracts so that each party bears responsibility for its own actions
 - How the two primary principles are implemented
 - Improve upfront planning and requirements definition
 - Selecting contract type
 - Performance measures
 - Fee strategies
 - Documenting Performance
 - Actionable performance data

Small Business Tenets of "Big 3"

- Mandatory Subcontracting of 30-35% with 50-65% of this to small business.
- The minimum sub-sets are:
 - Service-disabled veteran-owned small businesses: 3%
 - HUBZone small businesses: 3%
 - Small disadvantaged businesses: 5-10%
 - Women-owned small businesses: 5-10%
- Strengthen Small Business Performance Measurements
 - Performance Evaluation Measurement Plan
 - Past Performance Evaluations

Community Engagement

- Continue Outreach efforts.
- Addition of community day to acquisition planning process.
- Incorporate community commitment plans into proposals.
- Include planned execution and performance evaluations.


Headquarters Information Technology

PPPO Gaseous Diffusion DUF6 Conversion Facilities

Scope of Work

- Provide S&M for the conversion facilities
- Operate the conversion facilities to convert the DUF6 from the inventory at Paducah/Portsmouth to uranium oxide
- Reuse, store, transport and dispose of the DUF6 conversion process end-products
- Sell the aqueous hydrofluoric acid (AqHF) product; and, provide S&M services for the cylinder storage yards

- Removal of all deposits, hold-up, and equipment necessary to achieve criticality incredible and disposal cell waste acceptance criteria for uranium isotopes in the C-337 Uranium Enrichment Building

Los Alamos Legacy Cleanup Contract

Scope of Work

- Protection of groundwater resources and surface water quality from legacy contaminant migration through compliance monitoring and sampling programs

Carlsbad WIPP Transportation

Scope of Work

- Transportation of mixed and non-mixed Transuranic (TRU) waste, asbestos, and polychlorinated biphenyl (PCB) contaminated TRU waste from generator sites to WIPP
- Transportation of TRU waste between generator sites as listed in Appendix 1 (TRU Waste Storage Sites, Locations and Mileage)
- Transportation of training units or empty shipping packages to training/exercises
