# MOTION TO INTERVENE OF FLORIDIAN NATURAL GAS STORAGE COMPANY, LLC

Pursuant to 10 C.F.R. § 590.303, Floridian Natural Gas Storage Company, LLC (Floridian) files this motion to intervene in the above-captioned proceeding. Floridian states as follows:

#### CARIB APPLICATION

On March 25, 2016, Carib Energy (USA) LLC (Carib) filed an application to the U.S. Department of Energy Office of Fossil Energy (DOE/FE) requesting long-term, multi-contract authorization under Section 3 of the Natural Gas Act (NGA) to export over a twenty-year term

domestically produced liquefied natural gas (LNG) up to the equivalent of 1.3 billion cubic feet (Bcf) of natural gas per year to non-Free Trade Agreement (FTA) nations in Central America, South America and the Caribbean. Carib states that the LNG will be purchased from existing facilities owned and operated by Pivotal LNG, Inc. or its affiliates, transported over highways in ISO containers and exported from ports in the southeastern United States capable of accommodating LNG exports by ISO containers on ocean-going carriers.

## FLORIDIAN INTERVENTION

Floridian is developing a new natural gas liquefaction, storage, vaporization and truck loading facility near Indiantown in Martin County, Florida. Floridian holds a certificate of public convenience and necessity issued by the Federal Energy Regulatory Commission (FERC) under NGA Section 7(c) of the Natural Gas Act authorizing the new facility (the Floridian Facility). In addition, Floridian holds long-term, multi-contract authorization granted by DOE/FE under NGA Section 3 to export over a twenty-year term to non-FTA nations LNG produced at the Floridian Facility up to the equivalent of 14.6 Bcf of natural gas per year (the maximum annual send-out capacity of natural gas in its liquefied state via the truck loading station at the Floridian Facility), less the portion of that volume that may be under firm contract directly or indirectly to Carib (due to DOE/FE's having previously authorized Carib to export LNG from the Floridian Facility at the equivalent such maximum annual send-out capacity<sup>2</sup>). Floridian thus has a direct and unique interest in this proceeding that cannot be adequately represented by any other party. Accordingly there is good cause to grant Floridian intervention.
