ORDER GRANTING BLANKET AUTHORIZATION TO EXPORT NATURAL GAS TO CANADA

DOE/FE ORDER NO. 3961

JANUARY 4, 2017

I. DESCRIPTION OF REQUEST

On November 2, 2016, Active Energy Inc. (Active Energy) filed an application with the Office of Fossil Energy (FE) of the Department of Energy (DOE) under section 3 of the Natural Gas Act (NGA)¹ for blanket authorization to export up to 35 billion cubic feet (Bcf) of natural gas to Canada via pipeline.² The applicant requests the authorization be granted for a two-year term beginning on January 4, 2017. Active Energy is a Canadian corporation with its principal place of business in Burlington, Ontario, Canada.

II. FINDING

The application has been evaluated to determine if the proposed import and/or export arrangement meets the public interest requirement of section 3 of the NGA, as amended by section 201 of the Energy Policy Act of 1992 (Pub. L. 102-486). Under section 3(c), the import and export of natural gas, including liquefied natural gas (LNG), from and to a nation with which there is in effect a free trade agreement requiring national treatment for trade in natural gas and the import of LNG from other international sources are deemed to be consistent with the public interest, and applications for such imports and exports must be granted without modification or delay. The authorization sought by Active Energy to export natural gas to Canada, a nation with which a free trade agreement is in effect, meets the section 3(c) criterion and, therefore, is consistent with the public interest. This Order authorizes transactions with terms of no longer than two years.

² In the application, Active Energy inadvertently had listed the requested export volume as 0.0 Bcf for two years. This requested volume reflects an amendment to the application, which Active Energy submitted via email to DOE/FE on December 5, 2016.

ORDER

Pursuant to section 3 of the NGA, it is ordered that:

- A. Active Energy is authorized to export up to 35 Bcf of natural gas to Canada, pursuant to transactions that have terms of no longer than two years. This authorization shall be effective for a two-year term beginning on January 4, 2017, and extending through January 3, 2019.
- B. This natural gas may be exported by pipeline at any point on the border between the United States and Canada.
- C. **Monthly Reports:** With respect to the natural gas exports authorized by this Order, Active Energy shall file with the Office of Regulation and International Engagement, within 30 days following the last day of each calendar month, a report indicating whether exports of natural gas have been made. Monthly reports must be filed whether or not initial deliveries have begun. If no exports have been made, a report of "no activity" for that month must be filed. If exports of natural gas have occurred, the report must give the following details: (1) the country of destination; (2) the point(s) exit; (3) the volume in thousand cubic feet (Mcf); (4) the average purchase price of gas per million British thermal units (MMBtu) at the international border; (5) the name of the supplier(s); (6) the name of the U.S. transporter(s); and (7) the estimated or actual duration of the supply agreement(s)).

- D. The first monthly report required by this Order is due not later than February 28, 2017, and should cover the reporting period from January 4, 2017, through January 31, 2017.
- E. All monthly report filings shall be made to U.S. Department of Energy (FE-34), Division of Natural Gas Regulation, Office of Regulation and International Engagement, Office of Fossil Energy, P.O. Box 44375, Washington, D.C. 20026-4375, Attention: Natural Gas
