Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide federal funding to Rutgers University to manage the 28 Industrial Assessment Centers (IAC) through a portfolio of activities under policy guidelines established by DOE. The IAC's are located at universities around the country and conduct energy audits to identify opportunities to improve productivity, reduce waste, and save energy for small to medium sized manufacturers.

The proposed activities would include funding for Rutgers University to coordinate and evaluate operations and outreach activities at the IAC's through technical reviews of assessment reports; provide training and technical assistance; maintain and upgrade the IAC websites and databases; advance the deployment of an accredited energy engineering degree; develop technical and informational resources for IAC clients; and ensure program integration with other DOE manufacturing assistance programs.

Based on the review of the proposal, DOE has determined that the proposal fits within the class of action(s) selected above. DOE has also determined that: (1) there are no extraordinary circumstances (as defined by 10 CFR 1021.410 (2)) related to the proposal that may affect the significance of the environmental effects of the proposal; (2) the proposal has not been segmented to meet the definition of a categorical exclusion; and (3) the proposal is not connected to other actions with potentially significant impacts, related to other proposals with cumulatively significant actions, or an improper interim action. This proposal is categorically excluded from further NEPA review.
