ORDER GRANTING BLANKET AUTHORIZATION  
TO EXPORT NATURAL GAS TO MEXICO

DOE/FE ORDER NO. 4204

JUNE 29, 2018

## I. DESCRIPTION OF REQUEST

On June 6, 2018, Pharaoh Solutions LLC (Pharaoh Solutions) filed an application with the Office of Fossil Energy (FE) of the Department of Energy (DOE) under section 3 of the Natural Gas Act (NGA)<sup>1</sup> for blanket authorization to export up to 14.6 billion cubic feet (Bcf) of natural gas to Mexico via pipeline.<sup>2</sup> The applicant requests the authorization be granted for a two-year term beginning on the date that DOE/FE issues an order granting the requested authorization. Pharaoh Solutions is a Texas limited liability company with its principal place of business in Juarez, Chihuahua, Mexico.

## II. FINDING

The application has been evaluated to determine if the proposed import and/or export arrangement meets the public interest requirement of section 3 of the NGA, as amended by section 201 of the Energy Policy Act of 1992 (Pub. L. 102-486). Under section 3(c), the import and export of natural gas, including liquefied natural gas (LNG), from and to a nation with which there is in effect a free trade agreement requiring national treatment for trade in natural gas and the import of LNG from other international sources are deemed to be consistent with the public interest, and applications for such imports or exports must be granted without modification or delay. The authorization sought by Pharaoh Solutions to export natural gas to Mexico, a nation with which a free trade agreement requiring national treatment for trade in natural gas is in effect, meets the section 3(c) criterion and, therefore, is consistent with the public interest. This Order authorizes transactions with terms of no longer than two years.

<sup>2</sup> On June 22, 2018, Jesus Cobos, CEO for Pharaoh Solutions, emailed DOE/FE to clarify that Pharaoh Solutions is seeking blanket authorization to export up to 14.6 Bcf of natural gas, not the 0.02 Bcf volume it included in its initial filing with DOE/FE.

ORDER

Pursuant to section 3 of the NGA, it is ordered that:

A. Pharaoh Solutions is authorized to export up to 14.6 Bcf of natural gas to Mexico, pursuant to transactions that have terms of no longer than two years. This authorization shall be effective for a two-year term beginning on June 29, 2018, and extending through June 28, 2020.

B. This natural gas may be exported by pipeline at any point on the border between the United States and Mexico.

C. **Monthly Reports:** With respect to the natural gas exports authorized by this Order, Pharaoh Solutions shall file with the Office of Regulation and International Engagement, within 30 days following the last day of each calendar month, a report indicating whether exports of natural gas have been made. Monthly reports must be filed whether or not initial deliveries have begun. If no exports have been made, a report of “no activity” for that month must be filed. If exports of natural gas have occurred, the report must give the following details: (1) the country of destination; (2) the point(s) of exit; (3) the volume in thousand cubic feet (Mcf); (4) the average purchase price of gas per million British thermal units (MMBtu) at the international border; (5) the name of the supplier(s); (6) the name of the U.S. transporter(s); and (7) the estimated or actual duration of the supply agreement(s).

D. The first monthly report required by this Order is due not later than August 30, 2018, and should cover the reporting period from June 29, 2018, through July 31, 2018.
