ORDER GRANTING BLANKET AUTHORIZATION TO
IMPORT NATURAL GAS FROM CANADA

DOE/FE ORDER NO. 4210

JULY 20, 2018

I. DESCRIPTION OF REQUEST

On June 28, 2018, Sacramento Municipal Utility District filed an application with the Office of Fossil Energy (FE) of the Department of Energy (DOE) under section 3 of the Natural Gas Act (NGA)¹ for blanket authorization to import up to 100 billion cubic feet (Bcf) of natural gas from Canada via pipeline. The applicant requests the authorization be granted for a two-year term beginning on July 1, 2018.² Sacramento Municipal Utility District is a California municipal utility district with its principal place of business in Sacramento, California.

II. FINDING

The application has been evaluated to determine if the proposed import and/or export arrangement meets the public interest requirement of section 3 of the NGA, as amended by section 201 of the Energy Policy Act of 1992 (Pub. L. 102-486). Under section 3(c), the import and export of natural gas, including liquefied natural gas (LNG), from and to a nation with which there is in effect a free trade agreement requiring national treatment for trade in natural gas and the import of LNG from other international sources are deemed to be consistent with the public interest, and applications for such imports and exports, must be granted without modification or delay. The authorization sought by Sacramento Municipal Utility District to import natural gas from Canada, a nation with which a free trade agreement requiring national treatment for trade in natural gas is in effect, meets the section 3(c) criterion and, therefore, is consistent with the public interest. This Order authorizes transactions with terms of no longer than two years.

¹ Authority to regulate the imports and exports of natural gas, including liquefied natural gas, under section 3 of the NGA (15 U.S.C. § 717b) has been delegated to the Assistant Secretary for FE in Redelelegation Order No. 00-006.02 issued on November 17, 2014.

² Sacramento Municipal Utility District's blanket authorization to import natural gas from Canada, granted in DOE/FE Order No. 3836 on May 20, 2016, extends through June 30, 2018. On July 9, 2018, Mary Turner, a representative from Sacramento Municipal Utility District, requested via email that their authorization begin retroactively on July 1, 2018 to ensure Sacramento Municipal Utility District is able to continue operations.

ORDER

Pursuant to section 3 of the NGA, it is ordered that:

A. Sacramento Municipal Utility District is authorized to import up to 100 Bcf of natural gas from Canada, pursuant to transactions that have terms of no longer than two years. This authorization shall be effective for a two-year term which began on July 1, 2018, and extends through June 30, 2020.

B. This natural gas may be imported via pipeline at any point on the border between the United States and Canada.

C. **Monthly Reports:** With respect to the natural gas imports authorized by this Order, Sacramento Municipal Utility District shall file with the Office of Regulation and International Engagement, within 30 days following the last day of each calendar month, a report indicating whether imports of natural gas have been made. Monthly reports must be filed whether or not initial deliveries have begun. If no imports have been made, a report of “no activity” for that month must be filed. If imports of natural gas have occurred, the report must give the following details: (1) the country of origin; (2) the point(s) of entry; (4) the volume in thousand cubic feet (Mcf); (5) the average purchase price of gas per million British thermal units (MMBtu) at the international border; (6) the name of the supplier(s); (7) the name of the U.S. transporter(s); (8) the estimated or actual duration of the supply agreement(s); and (9) the geographic markets served (list State(s), U.S. Census Region(s), or general U.S. geographic area(s)).

D. The first monthly report required by this Order is due not later than August 30, 2018, and should cover the reporting period from July 1, 2018, through July 31, 2018.
