ORDER GRANTING REQUEST TO AMEND AUTHORIZATION TO
EXPORT NATURAL GAS TO REFLECT CORPORATE NAME CHANGE

DOE/FE ORDER NO. 3912-A

On October 31, 2016, the Office of Fossil Energy (FE) of the Department of Energy (DOE) issued DOE/FE Order No. 3912 (FE Docket No. 16-118-NG) under section 3 of the Natural Gas Act (NGA),¹ thereby granting Seneca Resources Corporation long-term authorization to export up to a total volume amount of 45.18 billion cubic feet (Bcf) of natural gas per year to Canada (equivalent to a total volume amount of 18,000 MMBtu per day) for a term of seven years and two months beginning on November 1, 2016.

On August 21, 2018, DOE/FE was notified that Seneca Resources Corporation had converted from a Pennsylvania corporation to a Pennsylvania limited liability company, effective

August 1, 2018.² As a result of this conversion, Seneca Resources Corporation's corporate name has been changed to Seneca Resources Company, LLC, effective August 1, 2018.³ Seneca Resources Company, LLC states that there has been no change in control, ownership or corporate structure.⁴ Seneca Resources Company, LLC requested that DOE/FE amend its authorization in DOE/FE Order No. 3912 to reflect its corporate name change.⁵

Finding good cause, DOE/FE hereby grants Seneca Resources Company, LLC's request to amend its authorization in DOE/FE Order No. 3912 to reflect its corporate name change. Accordingly, pursuant to section 3 of the Natural Gas Act, it is hereby ordered that DOE/FE Order No. 3912 is amended to substitute Seneca Resources Company, LLC as the authorized exporter of natural gas, as applicable, effective August 1, 2018. All other terms and conditions of DOE/FE Order No. 3912 shall remain in full force and effect.
