Rationale for determination:

The U.S. Department of Energy is proposing to provide federal funding to Purdue University in support of a project that focuses on evaluating the high-temperature corrosion of metal alloys and ceramic composites in molten chloride salts under well-controlled thermal, atmospheric, chemical, and fluidynamic conditions. The project would be completed in a single Budget Period.

Project activities include design and development of corrosion testing equipment, preparation of samples and salts, corrosion testing, and characterization of the samples after such tests. All activities would occur in a dedicated university laboratory facility at Purdue University. No new permits or authorizations, or modifications are needed and no changes to the facilities are necessary for this work.

The project would involve the use and handling of various hazardous materials, including metals and industrial solvents. All such handling would occur in-lab, and our organization is dedicated to proper hazardous material handling and disposal practices, so the project activities that involve these materials would pose no risk to the public. All hazardous materials would be managed in accordance with federal, state, and local environmental regulations. Existing university health and safety policies and procedures would be followed, including employee training, proper protective equipment, engineering controls, monitoring, and internal assessments.
