Supplemental Information

Dear Ms. Sweeney:

On February 26, 2019, Annova LNG Common Infrastructure, LLC ("Annova") filed an Application for Long-Term, Multi-Contract Authorization to Export Liquefied Natural Gas to Non-Free Trade Agreement Nations ("Application"). Annova submits the following supplemental information to the Application.

The lease option in effect in 2013, at the time of Annova's application to export to Free Trade Agreement nations, covered 295 acres. Since then the lease option has been amended several times. Each time, additional acreage was added to Annova's lease option. The lease option was amended twice in 2014. Then, in 2016, the lease option was amended and restated to include the current 731 acres. This amended and restated lease option will go into effect when Annova notifies the Port of Brownsville that it has determined that it will move forward with the Project.

The intrastate pipeline to which Annova refers at page 5 of its Application will be an approximately 9-mile, 36-inch intrastate lateral pipeline that will interconnect with intrastate

pipeline Valley Crossing Pipeline, LLC. The lateral pipeline will be constructed, owned, and operated by a third party. A discussion of the lateral pipeline, including a diagram showing its location, is included in the Draft Environmental Impact Statement issued by the staff of the Federal Energy Regulatory Commission in FERC Docket No. CP16-480.<sup>2</sup>
