Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

A9 Information gathering, analysis, and dissemination Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. (See also B3.1 of appendix B to this subpart.)

B3.6 Small-scale research and development, laboratory operations, and pilot projects Siting, construction, modification, operation, and decommissioning of facilities for smallscale research and development projects; conventional laboratory operations (such as preparation of chemical standards and sample analysis); and small-scale pilot projects (generally less than 2 years) frequently conducted to verify a concept before demonstration actions, provided that construction or modification would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible). Not included in this category are demonstration actions, meaning actions that are undertaken at a scale to show whether a technology would be viable on a larger scale and suitable for commercial deployment.

B3.15 Small-scale indoor research and development projects using nanoscale materials Siting, construction, modification, operation, and decommissioning of facilities for indoor small-scale research and development projects and small-scale pilot projects using nanoscale materials in accordance with applicable requirements (such as engineering, worker safety, procedural, and administrative regulations) necessary to ensure the containment of any hazardous materials. Construction and modification activities would be within or contiguous to a previously disturbed or developed area (where active utilities and currently used roads are readily accessible).

Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the University of North Carolina Chapel Hill (UNC-Chapel Hill) to design, develop, fabricate, and test perovskite/silicon tandem solar cells using a novel fabrication process. Solar cells would be fabricated via blade-coating and aerosol impaction-driven assembly (AIDA). The project would be completed over two Budget Periods (BPs), with a Go/No-Go Decision Point in between each BP.

Proposed project activities would include silicon bottom-cell fabrication, fabrication technique development/optimization, top-cell fabrication, perovskite/silicon tandem device fabrication/optimization, cost modeling, and stakeholder engagement. All activities would be completed in existing, purpose-built laboratory facilities, operated by UNC-Chapel Hill or its project partners, Arizona State University and the National Renewable Energy Laboratory. No changes in the use, mission, or operation of existing facilities would be required. Neither UNC-Chapel Hill nor any of its project partners would need to obtain any additional authorizations or permits in order to perform the work activities proposed as part of this award.

Project work would include the use and handling of various hazardous materials, including acids, solvents, lead containing substances, and reactive gases. All such handling would be performed in laboratory settings, in

accordance with each institution's established health and safety policies and procedures. All personnel involved with laboratory work would undergo health and safety training. UNC-Chapel Hill and its project partners would adhere to all relevant Federal, state, and local health, safety, and environmental regulations.

Nanoscale semiconductor nanoparticles would be produced and used as a coating material. Nanoparticles would be produced and collected entirely inside of a vacuum chamber. Any nanoparticles not deposited during the coating process would be collected on a HEPA filter between the deposition chamber and vacuum pump. No nanoparticles would be introduced into the ambient environment.

NEPA PROVISION

DOE has made a final NEPA determination.

Include the following condition in the financial assistance agreement:

Any work proposed to be conducted at a federal facility may be subject to additional NEPA review by the cognizant federal official and must meet the applicable health and safety requirements of the facility.

There are no extraordinary circumstances related to the proposed action that may affect the significance of the environmental effects of the proposal.

The proposed action has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

The proposed action is categorically excluded from further NEPA review.
