Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Policy 451.1), I have made the following determination:

Description:

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and audits), data analysis (including, but not limited to, computer modeling), document preparation (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. Rationale for determination:

The U.S. Department of Energy (DOE) is proposing to provide funding to the Spirit Lake Tribe for the design, permitting, construction and interconnection of a 1.5 MW capacity direct-drive wind turbine with associated access road and wind turbine pad. The wind turbine would be installed and maintained on Tribal Trust Land near Fort Totten in North Dakota. This NEPA determination is only for Task 1 of the approved Statement of Project Objectives. These tasks will help to more thoroughly define the remaining project activities and proposed location of the turbine. At this time there is not enough information to complete a thorough review of the construction and surface disturbing activities associated with the installation of the wind turbine at the proposed location. Once additional details regarding the design and siting are completed, another NEPA review will be required to assess potential impacts associated with the procurement, construction, and operation of the wind turbine.

FOR CATEGORICAL EXCLUSION DETERMINATIONS
