CHEVRON U.S.A. INC. FE DOCKET NO. 19-28-LNG

PROPOSED ACTION DESCRIPTION: Chevron U.S.A. Inc. (Chevron), a Pennsylvania corporation with its primary place of business in San Ramon, California, filed an application with the Office of Fossil Energy (FE) on March 5, 2019, seeking a blanket authorization to engage in short-term exports of liquefied natural gas (LNG) previously imported into the United States from foreign sources. Chevron seeks to export the LNG in a volume equivalent to approximately 72 billion cubic feet (Bcf) of natural gas on a cumulative basis for a two-year period commencing on the date of issuance of DOE's order.

Chevron requests authorization to export this LNG by vessel from the Sabine Pass LNG Terminal, owned by Sabine Pass LNG, L.P. and located in Cameron Parish, Louisiana, to any country with which trade is not prohibited by U.S. law or policy. This includes any country with which the United States currently has, or in the future will have, a free trade agreement (FTA) requiring national treatment for trade in natural gas, and with which trade is not prohibited by U.S. law or policy (FTA countries), and any other country with which trade is not prohibited by U.S. law or policy (non-FTA countries).

The application was submitted pursuant to section 3 of the Natural Gas Act and 10 CFR Part 590 of the Department of Energy's (DOE) regulations. No new facilities or modification to any existing facilities at the Sabine Pass LNG Terminal are required for Chevron to export LNG from that facility. DOE/FE's proposed action is to authorize the exports if DOE/FE determines that such exports are not inconsistent with the public interest.

[] There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer, I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
