On August 15, 2019, Energía Costa Azul, S. de R.L. de C.V. (“ECA”) and ECA Liquefaction, S. de R.L. de C.V. (“Liquefaction”) (jointly, “Applicants”) filed an application (“Application”) in the above-referenced docket seeking authorization for ECA to transfer to Liquefaction its existing long-term, multi-contract authorizations to export natural gas and liquefied natural gas granted in DOE/FE Order Nos. 4317 and 4364. The Applicants submit the following supplemental information to the Application.

As indicated in the Application, ECA is owned by Infraestructura Energética Nova, S.A.V. de C.V. (“IEnova”) and IEnova’s subsidiaries. Liquefaction is owned approximately 99.9% by ECA LNG Holdings B.V., which in turn, is a joint venture owned 50% by Sempra Energy (“Sempra”) and 50% by IEnova.

A majority of ownership interests (66.43%) in IEnova is held by indirect, wholly-owned subsidiaries of Sempra. The remaining ownership interests in IEnova are publicly-traded on the Mexican Stock Exchange (*Bolsa Mexicana de Valores*). With the exception of Sempra, no shareholder holds 10% or more of the ownership interests in either IEnova or the Applicants.



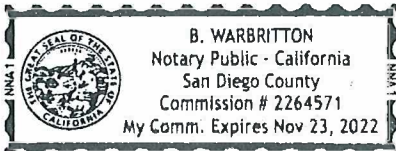
